Antique Booth Rules

BOOTH SPACES

Booth spaces are located in the Heritage Hall, a lockable enclosed building. The spaces vary in size to accommodate your individual needs. Booth locations will be assigned based on your space size and locations from last year. If you have additional needs or requests, please, notify us as soon as possible.

FEES

Booth fees are based on square footage. Fees must be submitted with the application. A confirmation letter will be sent on or before August 19th. The committee reserves the right to refuse any application. Written requests for cancellation/refund will be accepted until August 31st. After August 31st, refunds will be at our discretion.

SCHEDULE

Dealers must participate in **both** days. Antique booths are to be open from 10:00 AM to 6:00PM on Saturday and from 10:00 AM to 5:00 PM on Sunday. **NO MERCANDISE IS TO BE SOLD TO THE PUBLIC BY ANY DEALER BEFORE THE FESTIVAL OPENS EACH DAY.** No teardown will be permitted before 5:00 PM on Sunday.

RESTOCKING

If there is a need to restock during the day, golf cart with a small trailer will be available for assistance. Request this service at the information booth.

ADMISSION

Exhibitor passes (four (4) passes per application) will be available at set-up time. These passes will be your admission tickets to the Festival.

EXHIBITOR BOOTH APPEARANCE

We would like all dealers to use natural materials (canvas, burlap, muslin, linen, cotton, wood, etc.) to decorate their space in era appropriate colors. All modern equipment, (tables, chairs, racks, etc.) should be disguised. If you have any questions or concerns, the committee will be happy to assist you.

MERCHANDISE

The merchandise offered for sale should be antique or considered appropriate for an antique shop. The committee reserves the right to determine an item not appropriate for sale in the antique section.

COSTUMES

All participants must be in pioneer costume from opening to closing each day. Costuming used on Little House on the Prairie and clothing worn by the Amish are good representations of the era, and suitable for Festival wear. No modern jean dresses or skirts are to be worn.
